1. PURPOSE OF THE LOGBOOK

- Tracks clinical experiences and procedural skills.
- Ensures competency-based learning in clinical settings.
- Facilitates self-reflection and feedback from faculty.
- Patient interactions, and skills acquired.

2. LOGBOOK COMPONENTS

- Personal Details: Student's name, ID, academic year, and rotation details.
- Clinical Rotations: Departments and duration of curation.
- · Clinical Case Records: Patient encounters with diagnosis, management, and student's role.
- Procedural Skills: Checklist of required clinical skills (e.g., suturing, catheterization).
- Supervisor Feedback and Sign-offs: Evaluation by faculty members.
- Self-Reflection Section: Student's learning experiences and challenges.

3. LOGBOOK PROCEDURE

STEP 1: ORIENTATION AND LOGBOOK DISTRIBUTION

- At the beginning of clinical rotations, students receive a logbook template outlining the required competencies.
- Faculty members provide training on how to document cases and procedures correctly.
- Students are briefed on evaluation criteria and deadlines.

STEP 2: DAILY LOGBOOK ENTRY

Each day, students record:

Patient Encounters:

o Patient history, examination findings, diagnosis, and treatment plan.

o Student's role in patient management (observer, assistant, independent performer). o Faculty signature 2. Procedural Skills Performed: o Name of the procedure (e.g., IV cannulation, blood sampling, wound dressing). o Level of supervision (observed, assisted, performed under supervision, performed independently). o Supervisor's sign-off and comments. 3. Reflections on Learning: o Key takeaways from the day's clinical experience. o Areas for improvement and action plans. STEP 3: WEEKLY REVIEW BY FACULTY OR SUPERVISORS • Supervising faculty members review the logbook weekly. • They check for: o Completeness and accuracy of patient records. o Progress in procedural skills. o Student's reflections and engagement in learning. • Feedback – Ares to improvement STEP 4: FINAL LOGBOOK SUBMISSION AND SUMMATIVE ASSESSMENT • At the end of the rotation, students submit the completed logbook. • Faculty assess based on: o Completion of required cases and procedures. o Quality of documentation and reflections. o Professionalism and adherence to clinical guidelines.

o Feedback from supervisors.
